the outbreak situation of Coronavirus Disease

- 2. Any shareholders who would like to attend the meeting by themselves or its proxy having the rights to attend the meeting should strictly conform to the directives on COVID-19 of the Department of Disease Control of the Ministry of Public Health on the meeting date, especially the preparation of hygienic mask and alcohol gel for themselves sufficiently as well as should conform to the hygienic principles such as washing their hands frequently with water and soap or alcohol gel and wearing a hygienic mask.
 - Moreover, any shareholders who would like to attend the meeting by themselves or its proxy having the rights to attend the meeting shall present the 2nd dose certificate of COVID-19 vaccination through the mobile application or document. In case that shareholders do not get the vaccination or get only 1st dose, shall present the negative result (C) of Antigen Test Kit (ATK) not over 3 days at the Company's screening point.

Mandatory checks will now take place for all individuals entering the shareholders' meeting by checking their body temperature and taking the COVID-19 screening questionnaire as well as recommend them to wash their hands with water and soap or alcohol gel. The Company shall provide the alcohol gel sufficiently especially at the sharing area such as the meeting room, toilet and registration point.
